- 2. Delete RFP section Attachment 6.6. Pro Forma Contract, Section A.2.I. in its entirety and insert the following in its place (any sentence or paragraph containing revised or new text is highlighted):
  - I. Trip Charge To be included by the Contractor in a SOW and invoice as a separate line item. A trip Charge is the applicable regional fixed rate or flat fee in Contract Section C.3.b. for a round-trip to and from the SOW's listed job address. Refer to Attachment C Regional Map of Tennessee. Trip Charges are limited to a single round-trip per SOW unless approved by an Authorized Representative.
- 3. Add the following as RFP section Attachment 6.6. Pro Forma Contract, Section C.3.f. and renumber any subsequent sections as necessary:
  - f. Trip Charges are limited to a single trip per SOW unless approved by an Authorized Representative. Trip Charge is a fixed rate or flat fee for a round-trip to and from a service facility. Trip Charge to be added on its own line item on the SOW and invoice.
- **4. RFP Amendment Effective Date.** The revisions set forth herein shall be effective upon release. All other terms and conditions of this RFP not expressly amended herein shall remain in full force and effect.
